INFORMATION FOR STUDENTS

The Law Society of Prince Edward Island requires that students pass certain courses at Law School in order to be eligible to be enrolled as an articled clerk.

Required Courses

In order to be enrolled as an Articled Clerk in Prince Edward Island, the Law Society requires the successful completion of the following courses at law school:

- Canadian Constitutional Law
- Civil Procedure
- Contracts
- Criminal Law
- Ethics/Professional Responsibility
- Property Law
- Torts

and the successful completion 4 of 7 courses in the following subject areas:

- Criminal Procedure
- Commercial Law
- Corporate Law
- Evidence
- Family Law
- Wills/Trusts
- Administrative Law

If you have any questions about required courses, please contact the Law Society. The Law Society gives three scholarships each year to law students.

Scholarships Offered to Law Students

Each year the Law Society and Law Foundation give three \$2,000 scholarships to law students. The student must be enrolled or accepted for enrolment as a full-time student at an accredited university law school for the next academic year. Proof of Enrolment or acceptance for enrolment must accompany the application. The Scholarship Committee of the Law Society selects recipients. The selection is based on a scholastic attainment in the previous year of academic study and demonstrated financial need. The deadline for submission of applications is July 31 of each year.

commitment to and be an active volunteer in his or her community.

Application: Applicant must submit the following documentation for consideration for either

or both of the Law Society/Law Foundation and CBA Daphne Dumont

scholarships:

(1) Completed Application Form;

(2) Statement as to applicant's financial need or special financial circumstances.

(3) Official written confirmation of enrolment in an accredited law school from

the Admissions Office or the Office of the Registrar of the law school;

(4) Official transcript of marks for the previous year of study:

(6) Proof of CBA membership as of July 31 (if applicable)

Method of Selection: A committee selected by the Council of the Law Society of Prince Edward Island

shall determine the recipients of the scholarships each year.
