Re: William Tetley Award

Dear Professor Isaacs:

In 2014, The Canadian Maritime Law Association ("CMLA") organized an essay contest to honour of the late William Tetley, who taught and published on maritime law at McGill University for 35 years, was a past president of the CMLA and contributed significantly to the development of maritime law, both within Canada and around the world. Submissions were received and reviewed in late 2014 and early 2015. The Award was ultimately presented in 2015 to Danielle Scriven, a LL.M. student at Dalhousie University, for her excellent paper on ballast water management.

The Board of Directors of the CMLA now wishes to sponsor a second William Tetley Award competition in 2017. Once again, the Award will take the form of a monetary prize of between \$500.00 and \$1,000.00, to be awarded by the CMLA to Canadian authors of high-quality articles, papers, publications or other written materials of a maritime nature. Submissions need not relate only to maritime law, but may address any topic of an educational nature relating to



any aspect of the marine industry. The authors themselves may submit their works or someone else may do so on their behalf. Winning submissions will be published in the Canadian Maritime Law Association Journal (or reprinted there with the consent of the copyright holder, if already published elsewhere). The Award will be bestowed only where submissions considered to be of publishable quality are received. To review and evaluate submissions, and to decide on the winners, frequency and amount of the Award, the CMLA's selection committee will once again be chaired by P. Jeremy Bolger, a past president of the CMLA.

The CMLA hereby requests your cooperation in publicizing the Professor William Tetley Award 2017 among your members and in encouraging submissions to the selection committee. A notice is attached, which we would ask you to kindly distribute to your members and/or to post in a conspicuous location in your premises.

THE WILLIAM TETLEY AWARD 2017

The Award: The Canadian Maritime Law Association ("CMLA") has established a **literary prize**, to be called the "**William Tetley Award**" (the "Award").

Purpose: The Award is named **in honour of the late Professor William Tetley, C.M., Q.C.**, who taught maritime law at the Faculty of Law of McGill University in Montreal, for some thirty-five years, in recognition of his outstanding contribution to the development of maritime law and maritime law education, both in Canada and around the world.

Nature: The Award will take the form of a **monetary prize of between \$500.00 and \$1,000.00**, as determined by the selection committee, to be awarded to **Canadian authors** of high-quality **articles, papers or publications**.

Topics: Submissions need not be confined to topics of maritime law, but may be devoted to **any topic of an educational nature pertinent to the marine industry**.

Publication: **Winning submissions will be published in the Canadian Maritime Law Association Journal** (or republished there with the consent of the copyright holder if already published elsewhere).

Frequency: The Award will **not necessarily be granted every year**, but only on receipt by the selection committee of submissions it deems to be of publishable quality.

Submissions: Submissions (**in English or French**) may be made **by the authors** themselves or by **anyone acting on their behalf**. Submissions should be printed out on **8-1/2" x 11" paper**, accompanied by an **electronic copy on a CD-ROM in pdf format**, and sent to:

Submissions must include the **name, postal and email addresses and telephone number(s) of the author and the submitter** (if other than the author).

Deadline: Submissions must be received no later than **December 31, 2016**.

Submissions may be made at **any time** and will be **evaluated by the selection committee**. The committee will notify the author and submitter of its decision within a reasonable time following receipt of submissions.
