*Publishing with the DJLS means contributing to a 24-year track record of excellence in student legal scholarship. Our journal has been cited by courts at all levels, including the Supreme Court of Canada.*

#### Requirements

The DJLS publishes articles, case comments, notes, interviews, memoranda, and reviews relating to contemporary issues, only in Canadian or international law. (Note: We will not publish articles that focus exclusively on American domestic law). This year, to celebrate our 25th anniversary, we will also be accepting cartoons and illustrations with a legal theme.

Submissions are based on originality, contribution to existing legal literature, and writing style. The DJLS only publishes works of the highest quality. Authors selected for publication must agree to publish their paper exclusively with the DJLS. Authors who wish to withdraw their submissions at any point should notify the DJLS as soon as possible. We expect to contact successful authors in November 2015.

#### Prizes and Feedback

The top three articles selected for publication will receive cash prizes. The first place submission will receive **\$1,000**, while the second and third place submissions will receive **\$500** and **\$250**, respectively. High quality submissions that are not selected for print publication may be considered for online publication.

#### How to Submit Your Paper

2. Complete your profile by filling in the form.
3. Check the box that says "Register as: Author"
4. Click "Register"
5. Under Start a New Submission, click the link that says "CLICK HERE to go to step one of the five-step submission process".
6. Follow the on-screen instructions to submit your article for consideration before **11:59 PM on Friday, October 16, 2015.**

Note: We will not accept email submissions. To preserve impartiality in our editorial process, we kindly ask that you do not include the author's name in the filename or body of the submitted text. Papers should not normally exceed 15,000 words, including footnotes, and must conform to the Canadian Guide to Uniform Legal Citation (McGill Guide), 8th edition (2014).
