Working groups prepare policy briefs, draft public legal information materials, organize workshops, and conduct research on current or emerging constitutional law and Charter rights issues. Downtown Legal Services (DLS)

DLS is the Faculty's flagship public interest clinic. We have been providing innovative legal services to low income communities for almost 50 years. Working under the close supervision of expert staff lawyers, our law student caseworkers provide assistance in a variety of areas of law including crimi-nal, family, human rights, refugee and immigration, tenant housing and aca-demic appeals and offences. In addition to direct legal services, DLS runs an expansive community outreach and public legal education program. Given the current environment due to the COVID-19 pandemic, it is not pos-sible to run our 1L volunteer program as we have done in previous years. However, we will be putting out a general call for volunteers for special proj-ects as these arise throughout the year. Investor Protection Clinic (IPC)

The new Investor Protection Clinic at UofT provides free legal services and public legal education to members of vulnerable communities who are at risk of suffering harm, or may have suffered harm and loss, relating to their investments. The IPC gives law students unique opportunities to learn through assisting clients with their legal claims, developing and delivering public legal education, and collaborating with regulators and key stakeholders on policy projects and litigation to promote investor protection. Students, including 1Ls, can volunteer with our working groups (Explorer and CLEO) by applying through the Public Interest Lottery. Upper years can volunteer for the working group on Project SRO by applying by email at ipc.law@utoronto.ca by 12pm September 15, 2020 with a statement of interest (maximum 100 words).
